

「WeWa x MSIG iTravel Go 免費旅遊保險優惠」之條款及細則

1. 「WeWa x MSIG iTravel Go 免費旅遊保險優惠」(「優惠」)只適用於由 2026 年 6 月 15 日至 2026 年 8 月 15 日期間(包括首尾兩日)(「推廣期」)成功申請由安信信貸有限公司(「安信」)發行之 WeWa Visa Signature 卡或 WeWa Visa 白金卡或 WeWa 銀聯鑽石卡(「指定信用卡」)之全新客戶(「客戶」)。
2. 客戶如於現在或過往 12 個月內曾持有任何由安信發行之信用卡，將不獲贈任何優惠。
3. 客戶須於安信發出批卡通知起計 15 日內或於 2026 年 9 月 15 日或之前(以較早者為準)(包括首尾兩日)(「指定期間」)，成功確認指定信用卡可享總共 6 天的三井住友海上火災保險(香港)有限公司(「MSIG」) iTravel Go (單次旅程) - 計劃 C (亞洲) 免費旅遊保障優惠(「旅遊保險」)。每位合資格之客戶只可獲享優惠 1 次。
4. 旅遊保險將於客戶於指定期間內成功確認指定信用卡後 2 個月內以 2 個電子優惠碼形式透過 OmyCard 手機應用程式發送，每個電子優惠碼將可分別用於兌換一份 MSIG iTravel Go 免費三天(單次旅程) - 計劃 C (亞洲) 旅遊保險。詳情請於收到換領短訊通知後參閱 OmyCard 手機應用程式。
5. 客戶之指定信用卡賬戶於發出優惠換領短訊通知(如適用)及換領旅遊保險時(如適用)，必須仍然有效及信貸狀況良好(概由安信全權酌情決定)，否則安信有權取消發送旅遊保險而毋須另行通知。如因任何理由取消指定信用卡賬戶，所有該指定信用卡賬戶原有之優惠(如適用)及未發送之旅遊保險將被即時取消。客戶於指定信用卡發卡後 12 個月內因任何原因取消/被取消該指定信用卡賬戶發出的任何實體及/或電子信用卡(如適用)，安信保留向該指定信用卡賬戶收取等同旅遊保險保費價值之費用。
6. 優惠不可轉贈、轉讓、退換、兌換現金或其他優惠或獎賞。
7. 安信為旅遊保險的保單持有人，MSIG 全權負責安排、分發、承保及提供旅遊保險。安信並非旅遊保險之供應商，對有關旅遊保險之質素及其他事項概不承擔任何責任。
8. 旅遊保險數量有限，送完即止。如反應熱烈，安信可能需要補充貨量，一般需時約 2 至 3 個月。
9. 若安信認為客戶所提供的資料無效及/或涉及任何欺詐或不誠實行為及/或重複換領旅遊保險，安信有絕對酌情權及最終決定權拒絕送贈有關旅遊保險予客戶或保留於其有關賬戶內扣除已換領旅遊保險之保費價值的權利，而毋須作出任何通知。
10. 安信保留隨時取消優惠及/或修改有關條款及細則之權利而毋須作出任何通知。如有任何爭議，安信擁有最終決定權。
11. 如本優惠之條款及細則之中、英文版本有任何歧義，概以英文版本為準。

Terms and Conditions of " WeWa x MSIG iTravel Go Free Travel Insurance Offer "

1. "WeWa x MSIG iTravel Go Free Travel Insurance Offer" (the "Offer") is only applicable to new cardholder ("Cardholder") who successfully applied WeWa Visa Signature Card or WeWa Visa Platinum Card or WeWa UnionPay Diamond Card ("Designated Credit Card") issued by PrimeCredit Limited ("PrimeCredit") from 15 June 2026 to 15 August 2026 (both dates are inclusive) ("Promotion Period").
2. Cardholder who is currently holding and / or has held any Credit Card issued by PrimeCredit in the past 12 months is not eligible for the Offer.
3. Cardholders who successfully activate their Designated Credit Card within 15 days from the date of receiving card approval notification or by 15 September 2026 (whichever is earlier) (both dates inclusive) ("Designated Period") can receive a total of 6 days MSIG Insurance (Hong Kong) Limited ("MSIG") iTravel

Go (Single Trip) – Plan C (Asia) travel insurance (“Travel Insurance”) for free. Each Cardholder can enjoy the Offer once only.

4. The Travel Insurance will be sent as 2 e-codes via the OmyCard Mobile App within 2 months after the Cardholders successfully activated the Designated Credit Card during the Designated Period, each of the e-codes can be used to redeem a MSIG iTravel Go (Single Trip) – Plan C (Asia) Free 3-day travel insurance respectively. For details, please refer to the OmyCard Mobile App after receiving the SMS notification for the redemption.
5. The Designated Credit Card account must be in good financial standing on the date sending out Offer redemption SMS (if applicable) as well as redeeming the Travel Insurance (if applicable). If the Designated Credit Card Account is closed for whatever reason, all existing offer in the credit card account and Offer not yet sent to the Designated Credit Card account will immediately be forfeited (if applicable). PrimeCredit reserves the right to charge an amount equivalent to the premium of the Travel Insurance on relevant Designated Credit Card account if the Cardholder cancels any physical credit card and / or digital credit card (if applicable) of that Designated Credit Card account within 12 months from the date of card issuance.
6. The Offer is non-transferable, non-exchangeable, non-refundable and cannot be exchanged for cash or other offers or rewards.
7. PrimeCredit is the policyholder of the Travel Insurance. MSIG is solely responsible for arranging, distributing, underwriting and providing the Travel Insurance. PrimeCredit is not the supplier of the Travel Insurance and will not be responsible for the quality and other liabilities arising in connection with the Travel Insurance.
8. Travel Insurance is limited and while stocks last. In case Travel Insurance run out of stock due to overwhelming responses, PrimeCredit may take around 2 to 3 months for replenishment.
9. In case PrimeCredit deemed that the Cardholder provided invalid information and / or committed fraud or dishonest action and / or made duplicated Travel Insurance redemption, the relevant Travel Insurance is not offered to the Cardholder or the amount equivalent to the market price of the premium of the Travel Insurance is debited from the related accounts of the Cardholder at the sole and absolute discretion and decision of PrimeCredit without prior notice
10. PrimeCredit reserves the right to modify or cancel the Offer and/or amend these Terms and Conditions at any time without prior notice. In case of any dispute, PrimeCredit reserves the right of final decision.
11. In the event of any discrepancy between the Chinese and English versions of these Terms and Conditions, the English version shall prevail.
